ATF Jackpot

Ever wonder what motivates a person to become a "snitch" and work underground as a paid informant? How trustworthy is the evidence gathered by a person like this? In a highly publicized case in California, the ATF enlisted the help of a member of a well known motorcycle club to work as a paid informant. The felon received special consideration for past crimes he was involved in or accused of in return for his under cover work. The two operations he was involved in resulted in very few convictions and were largely unsuccessful, even though they involved infiltration, entrapment and prosecution of former club brothers. Ultimately, the U.S. Marshall's Office relocated the informant into a protection program at a cost of \$99,000. The ATF paid him \$197,220 since 2001 for his contributions to their investigations of clubs. There was an additional \$118,776 spent on protection of this informant and although the actual total is unknown, it is estimated that over \$415,075 has been spent grooming and protecting this undercover informant since 2001.
