I went online and put in the search engine (child abuse Wisconsin) and after a few minutes I came across B.A.C.A. I wrote in and gave my phone number and wrote what happened. I got a call about two hours later from them. We talked for a while and arranged to meet at my house.

About a week later they came and met with Patty and I. We told our story and B.A.C.A. agreed to help us! About 11/2 weeks later we heard the bikes and when we got outside were surprised by how many were there right around 20 B.A.C.A members showed up.

Patty was presented with a leather vest with the B.A.C.A. patch on it and also a B.A.C.A. teddy bear and skullcap. All the other kids got gifts as well. We all got B.A.C.A. shirts and confidence that someone cares.

The kids all had their pictures taken on the motorcycle. My youngest Adam had to have his picture taken on every motorcycle there!

The next week patty and I had court up in Shawano, as we pulled in the court parking lot we saw no one. Then we saw some of the B.A.C.A. members walking up and all of a sudden 15 to 20 B.A.C.A members were there.

As we went into the courthouse Patty whispered to me " I'm so glad their here mom and I'm so proud to call them family"! I put my arm around her and gave her a kiss!

We headed into the courtroom. Our side was packed, and as the court got started Patty grabbed my hand and smiled.

When they called her to testify, she held her head high and answered the questions asked.

She held her head high and looked at me and her B.A.C.A. family. When she was done testifying they let her leave the courtroom and Viper and many others followed her out while some stayed in the courtroom with me.

He was found guilty of felony child abuse!

After B.A.C.A. and I went to the victim witness office where Patty was gathering herself, we walked in, she came to me and I gave her a big hug and we both cried!

We finally left the courthouse and B.A.C.A. followed us from Shawano to Appleton just to make sure we got home safe.

Later in Sept we had a house warming/ reception/ Patty's 15 birthday party, a whole bunch of B.A.C.A. members showed up and they gave Patty a Harley sweater.

This folks is what being a brother and sister means. B.A.C.A. stood by me and mine and me and mine will stand by B.A.C.A.
