

The Veterans Administration (Hospitals) By: Skypilot

This month I would like to write about something that should have been written about along time ago, the VA Hospital system, or known by many Veterans "The testing place for Vets, to see if we can kill them".

I've been in the system for twenty plus years and have seen things from Nurse's leaving patients in wheelchairs in the rain, to letting Vets lay in their own body waste. I had a Club Brother die because the VA refused to accept part of a liver for transplant (which



part of a liver will grow into a whole liver), they had Brothers lined up to donate and their answer was "We want a whole one or nothing".

The American Veteran according to VA Hospitals are nothing more then lab rats. I'm proof of that I have been given medication and ask the side effects of the drug. I was told "I don't know you let us know", because of this I lost all my teeth due to a pain medication that was actually a horse tranquilizer, given a drug to stop smoking and it made me suicidal (CHANTEX), it increased my PTSD symptoms to the point I thought I was back in Vietnam and damn near shot my house up.

The people who work there for the most part are a bunch of ASSHOLES, there are a few, very few good ones. Most of them act like your taking up their time by asking a question and if you call into the Administrator they turn you over to a patient advocate who's only purpose is to set in their office and give Veterans a hard time for calling the head of the Hospital and let you know how lucky we are to even have a VA. The other day I was up to see my Psychologist for my PTSD and some other problems I was having. Anyway there is this one Doctor we call "THE TV NAZI" because he thinks the TV in the waiting room is his. He has come out turned stations, lowered the sound (most vets have hearing problems) and as far as unplugging it. Well it was a little to loud so I got up to lower it after asking other Vets, he happen to come out and I told him"I'm Lowing it", he then pushed me out of the way and told me "I'll take care of my TV" the only thing that kept me from ripping his heart out and feeding it back to him was another Vet came up and told me "he ain't worth loosing your benefits for"

By the time I got home I was pissed to say the least, so I got his personal e-mail and wrote the Director of the Veterans Administration and in formed him he needed to come down for a surprise inspection seeing D.C. is only two hours away. I just got a letter back and he couldn't believe this was going on and he would drop in unexpectedly for a visit and then let me know. I wrote back and told him "if I know when your coming I will meet you there and personally take you to the problem areas.

One day I was up there and this older lady was crying I ask if I could help. Well her twin brothers (one a POW in Japan, the other a POW in Germany) and she told me VA refused for years to give her brothers treatment even though they were POWs and American Veterans and they died because a bunch of people could care less about the American Soldier. No that stinks. A POW should have priority in any VA.

I just hope this visit the Head Man is going to make rips the Veterans Hospitals a new asshole. Well if your a Vet I sure hope your getting better treatment then the other 90% of Veterans are.
