But ABATE is not just about legislation, we have a stake in the education and safety of motorcyclists in Wisconsin also.

This past November, ABATE Region 1A; Milwaukee put together a meeting discussing roadway and construction hazards. ABATE Representative Paul Vita introduced our guest panel to a crowd of almost eighty bikers with representation from several clubs and organizations. I was sorry to see the lack of media coverage, except for Preacher, but was glad to see that our WIDOT Director and county executives felt it important enough to send their best. Milwaukee County Director of Public Works George Torres, Waukesha County Director of Public Works Richard Bolte, and Robert Anderson, planning engineer for the Southeastern Wisconsin DOT all made up an excellent panel to address our concerns. ABATE Founder Tony"Pan"Sanfelipo gave a PowerPoint presentation that showed some of the concerns of motorcyclists not only in the southeast, but the entire state. Several ABATE of Wisconsin Inc Board members were present and asked most of the questions in order to keep the meeting moving along, with a chance for attendees to ask a few questions toward the end. All attendee's were urged to fill out question forms that were given to our panel for follow up and discussions. Although our panel seemed almost smug at times, I believe for the most part they were very receptive to our concerns. Some issues proved to be simple to change (we'll see), and some would probably require legislation to change. But, above all, a line of communication was opened, and a considerable amount of knowledge was gained. I hope other ABATE regions decide to put meetings like this together in other parts of the state.


