WASHINGTON, D.C. - U.S. Senator Jim Inhofe (R-Okla.) today praised the passage by unanimous consent of his bill (S.1877) clarifying U.S. law to allow veterans and servicemen not in uniform to salute the flag. Current law (US Code Title 4, Chapter 1) states that veterans and servicemen not in uniform should place their hand over their heart without clarifying whether they can or should

salute the flag.

'The salute is a form of honor and respect, representing pride in one's military service,' Senator Inhofe said. 'Veterans and service members continue representing the military services even when not in uniform.'

'Unfortunately, current U.S. law leaves confusion as to whether veterans and service members out of uniform can or should salute the flag. My legislation will clarify this regulation, allowing veterans and servicemen alike to salute the flag, whether they are in uniform or not.'

'I look forward to seeing those who have served saluting proudly at baseball games, parades, and formal events. I believe this is an appropriate way to honor and recognize the 25 million veterans in the United States who have served in the military and remain as role models to others citizens. Those who are currently serving or have served in the military have earned this right, and their recognition will be an inspiration to others.'

**"The Moving Wall"**

A half-size replica of the Vietnam War Memorial is set for Warrens  
September 27 – October 1

"The Moving Wall," a half-size replica of the Vietnam Veterans Memorial in Washington, DC that serves as a solemn reminder of the dedication and sacrifice that 2.7 million American men and women of the Armed Forces gave to their country in Vietnam, is arriving at Warrens on Thursday, September 27th.

The Moving Wall is the only replica of the Vietnam Veterans Memorial. It remains the only one that is maintained by the same Vietnam veterans who silk-screened the first name onto the first panel at the beginning of 1983. Bringing The Moving Wall to Warrens will afford our residents the chance to experience a replica of this memorial.

The Moving Wall will open to the public at 12:00 noon on Thursday, September 27th and close on Monday, October 1 at noon. It will remain open for visitors 24 hours per day, rain or shine. A ceremony is schedule for 6:15 pm on Saturday, September 29th.

The concept of The Moving Wall began in 1983 by members of the Vietnam Veterans Memorial Fund, Inc. and, after construction was completed, was first displayed in Texas in 1984. It was funded using only public contributions, and it is owned and administered by the Vietnam Combat Veterans, LTD. The replica has appeared in more than 1,000 communities across the nation, and the stop in Warrens will be one of two stops in the state of Wisconsin this year.
